4. format the data to GS1net standards; and
5. upload the file to the GS1net data repository for publication to the relevant buying community.

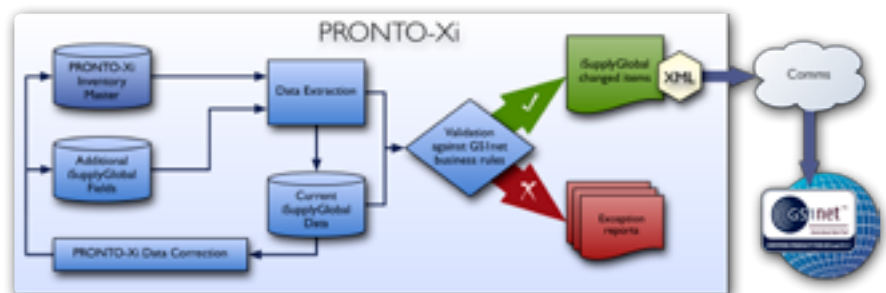
In accordance with GS1net design requirements, product and pricing information is grouped according to trading partner to ensure the security of information provided to each trading partner.

The integrated architecture of PRONTO-Xi iSupplyGlobal means that relevant product and pricing information goes directly from your PRONTO-Xi ERP to the GS1net data repository. From there, your trading partners can download the specific product catalogue that relates to them and automatically import it to their merchandising and procurement systems. Subsequently, incoming purchase orders will be accurate because there has been no manual intervention in getting the data into the trading partners' systems.

Another layer of efficiency saving you time and money is achieved by only having to publish your product updates once; each trading partner can then log in to GS1net and download their updates when they choose. This "one to many" process eliminates the need to supply discrete product updates to each trading partner.
